A total of 19 Post Graduate Courses (PGC) on Basic Occupational Safety and Health (BOSH) Training for the period, September 2017 to July 2018.

The six-day course is designed for nurses as required by the Bureau of Working Conditions (BWC) of the Department of Labor and Employment (DOLE) and in compliance with Rule 1960 of the Occupational Safety & Health Standards requiring all nurses in OSH to take up the Basic Occupational Safety & Health course.

It aims to equip nurses with the basic knowledge and skills in identifying safety, health, and environmental hazards, determining appropriate control measures, and developing and implementing OSH policies and programs.
